

ADDENDUM NO. 2 Issued April 30, 2024

TO

REQUEST FOR PROPOSALS

For the Marketing, Brokerage, Sale and Removal of
Operable Heavy Equipment Located at the Hartford Connecticut
South Meadows Site

(RFP Number 24-AUTH-008)

Note: Entities submitting a Proposal are required to acknowledge this and all Addenda in Section 4 of the Proposal Form.

1. RESPONSES TO QUESTIONS

This Addendum consists of responses by the MIRA Dissolution Authority (the "Authority") to written questions received per the deadline specified in Section I.C. of the RFP.

1.	Question	At the start of the meeting, you stated that the "Proposal Agreement" did not require any particular MIRA form or format but could be a Word Document covering the stated proposal contents. However it was stated there were required disclosure forms and background questionnaires (Attachment F and Attachment G?) that needed to be completed that are PDFs accessible via links to your RFP Site and downloaded into Microsoft Word and filled out accordingly. I printed out the 83 pages labeled RFP Number 24- AUTH-008. Were the pdf forms included in those 83 pages? Regardless of method, do those have to be filled out, printed and be included in the sealed proposal package?
	Answer	 The Proposed Agreement is included as Attachment C to the RFP. Section I.G.7 of the RFP (Business Exceptions) allows a Proposer to propose exceptions to this Proposed Agreement. Section I.G of the RFP specifies the contents that would constitute a Proposal. That includes a mix of items that are form-specific and items that are not form specific: The items specified in I.G.1 through 5 and I.G.7 are not form-specific and are designed to give proposers as much freedom as practicable to complete those narratives. Sections I.G.6, I.G. 8 and I.G.9 reference 4 forms which are also included as Attachments D, E, F, and G of the RFP. Those forms can be found in PDF format within the 83 page RFP. Separately those forms/exhibits can also be downloaded from the Authority's website in Word format. Links to each of those word documents are with the other documents related to this RFP on the Authority's website at https://www.ctmira.org/business-links/current-bids-rfp-rfq.
2.	Question	Would the committee allow for us to submit a Proposal A which would propose
۷٠		for the transport and auction of the equipment at our facility and Proposal B
		which would be a timed auction with the equipment sold virtual from the MI-RA locale? Respecting your neutral position, I won't go into detail but I am
		asking if two proposals would be acceptable.

	Answer	Proposers can include multiple alternatives within their proposal (for purposes of this answer each an "Alternative"). Proposer should provide sufficient detail about each Alternative in the proposal narratives as specified in Section I.G. 4 and I.G. 5 of the RFP to allow the Authority to evaluate each Alternative. Pro-			
		posers should also provide a Proposal Price Form (RFP Attachment F) for each alternative and detail whether they would have different Business Exceptions in accordance with I.G.7 for each Alternative. However, unless the alternatives are managed by two different legal entities (such that each really would be a			
		separate Proposer), a Proposer would not be required to submit two completely different title pages (in accordance with I.G. 1), cover pages (in accordance with I.G.2), tables of contents (in accordance with I.G. 3), Proposal Forms (RFP Attachment D), nor the forms specified in sections I.G.8 and I.G.9 of the RFP.			
3.	Question	During the site tour there were two units, 4119, an Older International Truck Tractor? and 4009, Ford L9000 Vac Truck, that were outside the Maneuvering Hall and were mentioned as possible additions to the operable list. Are they being added to this RFP?			
	Answer	Yes, these items are being added to this RFP. See attachment 1 to this RFP, which replaces Exhibit A. This attachment adds items 44, 45 and 46.			
4.	Question	During the site tour, staff mentioned that there may be hour meter readings on record that were taken at the point of idling e the equipment. That may be of some help when deciphering potential value vs costs involved in getting the items in a operational condition for pre-sale marketing and staging			
	Answer	Each of the items listed in the RFP were last operated in June 2023 by the Authority's former facility operator (NAES), or its maintenance contractor (HO Penn). At that time, each item was determined to be in working order.			
		In addition to adding items 44, 45 and 46 (as specified in Question 3 above), the attached revised RFP Attachment A includes two additional columns which show the last date for which the Authority has a mileage/hours record as well as the mileage/hours recorded at that time.
